There is some CCTV and the bid would seek to provide an additional camera in the skate park areas to be recorded to hard drive. <i>Gateshead</i>	Local Problem Solving - Violent Crime Interventions	The funding supports an audit of violent crime cases from 2013 to date to understand the context of violent crime and to develop bespoke evidence based perpetrator interventions and additional support for victims. There will be an arrest referral officer from the voluntary sector who will work in the cells and in the community to engage with and provide support to the perpetrators of violent crime. Following arrest and bail they will work with perpetrators to determine if there are any interventions that could be appropriate. Mediation, 1 to 1 support, substance misuse, anger management, RJ. Following successful engagement courts will be provided with a statement that the perpetrator has recognised their faults and taken necessary steps to change their behaviour. The funding will also recruit volunteers to work with the most vulnerable victims of crime and ASB. There would also be an opportunity to offer early intervention to perpetrators. This enables bespoke referrals to be made to those agencies based in that area. • Enhanced victim information to improve arrangements to support the victim. • Security details and memorable questions for victims to set up for their case file. • Victim vulnerability and risk assessment questions embedded in the report form. • Individual agency service standards are embedded in the updates on the case-file. This enables each action taken in relation to a case to be monitored against service standards. • Individual agency caseload feature to access case referrals, enquiries and reported incidents by their agency.
