112018	<p>Under Freedom of Information rules, I would like to be advised of the following:-</p> <ol style="list-style-type: none"> 1) Exactly how many actual 'Hate Crimes' against ordinary members of the public have been recorded by Northumbria Police? 2) Exactly how many actual 'Hate Crimes' against these LGBT people have been recorded by Northumbria Police? 3) The total cost of employing and training these 'advocates', all of whom are presumed to be capable of 'advising' sworn and presumably competent serving members of Northumbria Police? 4) May I also be advised whose idea this was, the reasons for agreeing with the spending of this taxpayers cash, and how did Northumberland manage to survive this long without the 'advocacy' and knowledge of these 'advocates' before now? 	<p>Thank you for your e mail dated 5 April 2018, in which you made a request for access to certain information which may be held by the Police and Crime Commissioner for Northumbria.</p> <ol style="list-style-type: none"> 1) No information held. The recording of crimes is an operational matter which remains under the remit of the Chief Constable, therefore you may wish to re-direct your request to Northumbria Police. 2) As per the above. 3) During the 2017/18 and 2018/19 financial years the LGBT Federation applied for funding for this project through the PCC's Supporting Victims Fund. In 2017/18 the PCC agreed to contribute £2000 towards the project and in 2018/19 the PCC has agreed a contribution of £3000. The Volunteer LGBT Advocates help to strengthen our support for victims of LGBT Hate Crime in the Northumbria Area. 4) The Office of the Police and Crime Commissioner felt that this project was worthy of funding to help to combat LGBT Hate Crime, as many victims of LGBT hate crime find it difficult to report what has happened to them. It is important to have these specially trained volunteer advocates to build confidence in those who have suffered abuse and to also provide emotional support to victims following a crime. This supports delivery of the Police and Crime Plan.
